Recommended Dosage	Typical dosage rates of SikaGrind®-116 RM ZA are between 400 – 800 ppm of raw material .The optimum dosage to achieve the desired characterist- ics shall be determined in plant trials. For consistent results, SikaGrind®- 116 RM ZA must be accurately dispensed.
Dispensing	SikaGrind®-116 RM ZA is added onto the raw material mill feed shortly be- fore the mill entrance or directly into the grinding mill (first or second com- partment). Suitable dosage pumps with adjustable flow rates shall be used for accur- ate dosing. Note: Periodically, the end of the additive tube/hose shall be checked to ensure, that it is not blocked!
